

## Frequently Asked Questions (FAQs) – Budget and MTFP Consultation

### 1. What is this consultation about?

We are consulting on the Combined Authority's **draft Budget for 2026–27** and **Medium-Term Financial Plan (MTFP) for 2029–2030**. These proposals outline how we plan to allocate funding, manage financial pressures, and invest in key priorities over the next four years.

### 2. Why are you consulting?

Although the Combined Authority is not legally required to consult on its Budget, we believe it is important to involve residents and stakeholders in decisions that affect the region. Your views will help shape the final proposals presented to the Board in January 2026.

### 3. What will my feedback be used for?

Your feedback will be analysed and summarised in a report to the Combined Authority Board. It will help inform decisions on the final Budget for 2026–27 and the Medium-Term Financial Plan for 2029–2030.

### 4. Who can take part?

Anyone can take part — residents, businesses, community groups, and partners. You don't need to have detailed knowledge of finance to share your views.

### 5. How do I respond?

### 6. What documents should I read before responding?

The draft Budget and MTFP proposals are supported by five technical appendices covering assumptions, revenue and capital budgets, income budgets and project reprofiling. You don't need to read all of them to take part, but they are available if you want more detail.

### 7. How long does the questionnaire take to complete?

The questionnaire takes around **5–10 minutes** to complete.

### 8. What is the Mayoral Precept and will it change?

The draft Budget assumes that the **Mayoral Precept remains at its current level of £36 per Band D property** for 2026–27. We are asking for your views on the overall Budget and MTFP, including this assumption.

### 9. Will my responses be anonymous?

Yes. Individual responses are not attributed to named individuals. Comments may be summarised to reflect themes and views across respondents.

**10. Can I submit a response on behalf of an organisation?**

Yes. If you are responding on behalf of an organisation, please state this clearly in the questionnaire or email.

**11. What happens after the consultation closes?**

All responses will be reviewed and a Consultation Report will be prepared for the Combined Authority Board. Final decisions on the Budget and MTFP will be made in January 2026 and the approved documents will then be published on our website.
